Welcome to Class Act Productions! To protect all persons involved and to insure a safe, enjoyable and professional production, please note the following requirements:

1. Student cast members are required to pay a \$375 participation fee to be in this production. Adult cast members are asked to pay \$200.  
*Note: This fee covers a portion of the cost of sets and scenery, costumes, props, production salaries and insurance.*
2. Each participant must complete and turn in the following forms and contracts. **NO ONE WILL BE ALLOWED TO PARTICIPATE IN THIS PRODUCTION WITHOUT THESE ITEMS.**
  - Participation Contract
  - Musical Production Release Form
3. Be on time and prepared for rehearsals. Be sure to check in with the Stage Manager when you arrive.
4. Directors must be notified in case of an absence from rehearsal. If you are absent without prior notice, when your scene is blocked, you could be cut from the scene.
5. Frequent absences may be cause for dismissal from the show.
6. It is expected that cast members cooperate with reasonable requests to alter their personal appearance for a particular character role in the production.
7. Rehearsal schedules are subject to change. If you miss a rehearsal, it is your responsibility to find out what announcements or changes you may have missed.
8. Continually disruptive behavior will not be tolerated and will result in dismissal.
9. Remember, there are no small parts! Your role is an important part of the show. Creating a quality production takes teamwork and the cooperation of all participants.
- 10. Taking photos and videos of rehearsals and/or performances are a violation of our license agreements. Please help us protect our ability to acquire the rights for future productions by refraining from taking unauthorized pictures and videos.**

*\* Failure to pay the participation fee, or to volunteer (or pay the opt-out fee) may result in loss of privilege to participate in future productions.*

## CLASS ACT PRODUCTIONS

### MUSICAL PRODUCTION RELEASE FORM

As the parent and/or other legal guardian of the named participating child, I desire that the named child enjoy the benefits of his/her participation in the production of **THE SOUND OF MUSIC** (name of the theatrical production), (hereinafter "referenced production") as well as all rehearsals, construction, practices and other preparation for the referenced production, to be put on by CLASS ACT PRODUCTIONS, a Texas non-profit corporation. I am fully aware that there are risks including risks of personal injury associated with any endeavor such as the referenced production to be undertaken by CLASS ACT PRODUCTIONS. With full knowledge of such risks and in consideration of the benefits to be enjoyed by the named child by virtue of his/her participation in the referenced production, I, as parent or other legal guardian of the named child, do freely and knowingly enter into this agreement and accept the representations contained herein on behalf of the named child.

I freely and knowingly release, discharge, waive, and give up any and all claims which the named child might have for personal injury or for damage to his/her property, which might occur as a result of his/her participation in the rehearsals, construction, practices or other preparation for the referenced production, and do further agree to indemnify and hold harmless CLASS ACT PRODUCTIONS from any and all claims of whatever type or nature that said child could ever bring as a result of his or her participation in said theatrical productions.

I also agree that under no circumstances will the participating child's family members, executors, administrators, or assigns, including, but not limited to the undersigned, prosecute or present any claim for personal injury or property damage against CLASS ACT PRODUCTIONS, or any other participant in said production, or the officers, directors or agents of CLASS ACT PRODUCTIONS, for any cause of action or claim which may arise from the named child's participation in the referenced production or any related activities.

I further agree that should any claim be presented or prosecuted, then I or my estate shall defend, indemnify, reimburse, and hold harmless CLASS ACT PRODUCTIONS and its officers, directors and agents of CLASS ACT PRODUCTIONS from all such claims, or causes of action, by whomever made or presented, including but not limited to any claims of any kind that may arise as a result of the negligence of CLASS ACT PRODUCTIONS, its directors, officers, employees, and agents harmless from their own acts of negligence.
